PART II: ORGANISATIONAL UPDATE

PART I: PROGRAMME UPDATES

This report provides an overview of activities undertaken in 2024-25, clustered under our thematic focus areas: Sexual Harassment at the Workplace, Adolescent Concerns and Early Marriage, Gender-Based Violence, Gender and Consent, Participation as panellist in meetings and the Feminist Law Archives. Part one of the report pertains to programme updates, while part two pertains to organisational updates.

I. Sexual Harassment at the Workplace Law

Seven collaborative workshops were organised by PLD, and additionally, we are regularly invited as resource persons to conduct sessions for other organisations. Together, through all the training workshops and sessions, across seven states, we reached out to 410 participants in all. The profile of the participants who we part of the workshops include members of internal and local committees, senior management in private and state government bodies, lawyers, grassroot and community workers, driving trainees, and university students; each a catalyser, change agent, or senior functionary, with the potential of impacting their fields of operation significantly.

II. Early, Child Marriage (CEM) and Adolescent Concerns

PLD's work over the last decade on the connected themes of child and early marriage (CEM) and adolescent sexuality has been collaborative in nature, with action research, dialogues along with case law studies, which have significantly reframed the understanding of child marriage and the law, highlighting the selective use of the law. These findings caution against over-reliance on law and criminalisation, while emphasising the value of welfare to empower girls from vulnerable communities who are most vulnerable to early marriage. Through dialogues with civil society organisations, representations to institutions and government bodies, and meetings, PLD continues to drive conversations, forging connections to strengthen an evidence based understanding of interventions that can be transformatory and empowering for girls. The following events were organised.

(A) The Adolescent Question - Feminist Co-learning Journeys

To deepen the discussion on issues affecting adolescent rights, PLD organised a national level workshop from November 18 - 21, 2024 in Sanand, Gujarat which



together brought participants from 19 partner organisations across ten states (Vijayawada, Andhra Pradesh; Guwahati, Assam; Delhi: Ahmedabad, Vadodara, Bhuj, Gujarat; Pune. Mumbai. Maharashtra: Bhubaneshwar, Odisha; Udaipur, Ajmer, Rajasthan; Chennai, Tamil Nadu: Kolkata. West Bengal: Noida, Uttar Pradesh) with whom PLD's work adolescents evolved. We

traced milestones in conceptual language and field intervention, which evolved from working with each other. In the spirit of feminist co-learning, we made interlinkages between the personal - our work - the law to unpack complex realities of adolescents in law and society. Our resource pool included NCAAC members, who enriched the discussions through intersectional perspectives.

(B) State level workshops in Rajasthan and West Bengal:

PLD organised two state level workshops on child and early marriage (CEM) and adolescent sexuality in collaboration organisations and state level networks in Rajasthan and West Bengal, to unpack competing discourses on criminalisation on one side and affirmative action to support girls in vulnerable contexts on the other.

Resource persons were drawn from NCAAC member organisations, such as Indira Pancholi from MJAS, Bharat from Vishakha, Madhu Mehra from PLD, Swagata Raha from Enfold Proactive Health Trust.





A total of 34 participants from various districts across Rajasthan, including Alwar, Banswara, Bikaner, Chittorgarh, Jaipur, Khichan, Rajsamand, and Udaipur, took part in the workshop which was organised on July 4-5, 2024 in Jaipur, Rajasthan, representing a diverse regional spread.

2. With Swayam [in collaboration with BHABNA network and NCAAC]

This workshop which was organised on July 19-20, 2024 in Kolkata, West Bengal, brought together 56 participants from different zones of Kolkata. The sessions fostered discussions on key issues, encouraging collective reflection and strengthening local engagement.

(C) Publication - Reprint of Booklet on Protection of Children against Sexual Offences Act (POCSO) - Bal Yaun Soshan par Kanoon



Originally published in 2016, Bal Yaun Soshan par Kanoon is a comprehensive Hindi resource on the Protection of Children from Sexual Offences (POCSO) Act, 2012 and its intersections with Juvenile Justice Act, Criminal Procedure Code, and the National Commission for Protection of Child Rights Act. It is perhaps the only comprehensive law primer in Hindi, and continues to be in demand, having been updated to its second edition in 2018. To meet the continuing demand, the second edition was reprinted.

III. Gender Based Violence and the Law

The Gender Based Violence (GBV) capacity building workshops organised by PLD, focus on equipping stakeholders with knowledge of law, rights-based approaches to case work addressing domestic violence along with other forms of gender based violence. By strengthening capacities at various levels, PLD contributes to a broader movement for

justice, gender equality, and systemic change in addressing gender based violence and discrimination.

(A) Capacity Development

1. Mahila Panchayat Members Training with Action India

Action India, established in 1976, has been actively working to empower women and address gender-based violence through various initiatives, including the Mahila Panchayat (MP) program. Currently, six Mahila Panchayats (Dakshin Puri, Seemapuri, Sunder Nagri, Janta Mazdoor Colony, Dharampura, Jahangirpuri)



operate across different of Delhi, districts independently managed by India. These Action **Panchayats** serve as community-based redressal mechanisms. providing women with safe spaces, resolution, dispute counseling, legal aid, and development leadership opportunities.

PLD, in collaboration with Action India, conducted workshops on April 23 - 25, 29, 2024; May 7, 8, 11, 14, 2024 in New Delhi, with 400 Mahila Panchayat members in April and May 2024 to strengthen the legal knowledge and case-handling skills of Mahila Panchayat members. The training focused on assessing existing knowledge, safe use of communication technology in casework, and understanding key legal frameworks, including the POCSO Act, Domestic Violence Act, Sexual Harassment at Workplace Act, and recent amendments in gender-based violence laws. These sessions aimed to enhance the capacity of Mahila Panchayats, equipping members with practical skills and legal awareness to support survivors more effectively.

2. Mahila Panchayat Leadership Training with Action India

PLD and Action India organised a two-day residential training on June 5-6, 2024, in New Delhi, with 100 Mahila Panchayat leaders, focusing on women's panchayats and feminist justice. The training aimed to deepen the understanding of justice, equality, and freedom through discussions, group activities, and historical perspectives on women's movements.

3. Samta Sakhi/Samanvayak (gender cadres) Legal Training with Pradan

PLD in collaboration with Pradan conducted a training session on February 14 - 15, 2025 in Bhopal, Madhya Pradesh, for 30 Samta Sakhi/Samanvayak (gender cadres) of the Madhya Pradesh State Rural Livelihoods Mission (MPSRLM), focusing on legal frameworks and women-specific laws under the new criminal law - BNS. The

session aimed to strengthen their understanding of legal rights and equip them with the knowledge to support gender justice initiatives within their communities.

IV. Gender, Consent and the Law


PLD's consent initiative with youth constituencies aims to shift the focus of the consent conversations to understanding the self, one's actions, decision making processes and ability to navigate power and external pressures. A preventive approach, this initiative bolsters the work on sexual harassment, through working with youth towards raising self-awareness, and fostering dialogue on consent and rejection through films. In this period, we conducted such events, through film symposiums in the following colleges:

- PLD with Ashoka University, Sonipat | April 13, 2024 | Sonipat, Haryana (45 students)
- PLD with Sai University, Chennai | May 18, 2024 | Chennai, Tamil Nadu (50 students and professors)

V. Feminist Archiving

The Feminist Law Archives, a repository of women's movements engagement with law, rights, oral histories and cultural expressions of rights has grown over the years. We recorded songs, memories and oral histories of feminists who have contributed to pioneering moments and change, besides adding more documents. A growing concern about archiving feminist histories within the sector is evident in increased efforts in archiving, discussions and forums in which we participated and presented.

(A) Ways of Seeing and Being Series II, Episode 4 - Mahaila Samakhya



An episode of PLD's Ways of Seeing and Being Series II, was created with Abha Bhaiya and Kalyani Menon Sen to record their transformative journey with the Mahila Samakhya Programme, dedicated to empowering women from socially and

economically marginalised groups in rural areas. Through this episode, Abha and Kalyani share their memories and reflections on the Mahila Samakhya journey.

(B) Rethinking the Trajectory: From Women's Archives to Feminist Archiving

A workshop organized by the RCWS, SNDTWU and DWGS, SPPU on February 7-8, 2025, in Pune. PLD team presented its experience of archiving over the decade, engaged with other archiving initiatives and participated in the discussions.

(C) Asian Women's Film Festival

The International Association of Women in Radio and Television (IAWRT) dedicated two panel discussions on the theme of Memory as Movement - Archiving Feminist Histories on March 6, 2025, as part of marking 20 years of the Asian Women's Film Festival in 2025. PLD was part of the panel discussions to present organisational approaches archiving within its work and through the digital repository of Feminist Law Archives.

As part of celebrating feminist histories and archiving efforts, IAWRT curated the work of 10 feminist organisations, including PLD. The exhibits of our journey, posters and publications, together with others, was a matter of pride and joy for us.



VI. Participation as panellist in meetings

PLD was a panellist in the following discussions and meetings:

1. Sexual Harassment at Workplace Law

- POSH Act and LCs: Let's take a Pause: PLD presented on the challenges related to Local Committees and participated in a consultation organised by Jagori on January 22-23, 2025 to discuss the implementation of law for unorganised sector women workers.
- National Consultation on 'Understanding the nature, forms and implications of structural violence against rural women in the context of agrarian distress' organised by SOPPECOM in collaboration with FPC, ISST and MAKAAM on

October 22nd-23rd, 2024 - PLD presented on challenges faced by unorganised

sector women workers in accessing redress for under sexual harassment law.

- UN Women working group on Sexual Harassment at the Workplace Law on September 19, 2024.
- Action Plan for Safety in Public Places for Women in Delhi on August 26, 2024, to brainstorming on suggestions for women's safety in public places in Delhi.
- India Rural Colloquy (4th edition) organised by TRIF on August 8, 2024, PLD presented on the challenges related to Local Committees to address sexual harassment against women workers in the unorganised sector.
